- 3. CREDIT CHECK:** The undersigned, hereby grants CESCO permission to perform a credit check on the customer listed below as well as the personal guarantee(s). CESCO has the right to grant or deny the extension of credit to any customer at its sole and absolute discretion. In the event of default by the customer in the performance of any of the terms and conditions hereof, CESCO may thereupon proceed to collect from the customer the entire balance due.
- 4. Governing Law; Exclusive Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of the state of Idaho. Each party hereby irrevocably and unconditionally consents to submit to the exclusive jurisdiction of the courts of the state of Idaho and the United States of America located in the City of Boise, Idaho, for any actions, suits or proceedings arising out of or relating to this Agreement, any equipment purchased, leased or rented by customer from CESCO, or any parts and/or service provided by CESCO to customer (and agrees not to commence any such action, suit or proceeding except in such courts). Each party hereby irrevocably and unconditionally waives any objection to the laying of venues of any such action, suit or proceeding in the courts of the state of Idaho or the United States of America located in the City of Boise, Idaho, and hereby further irrevocably and unconditionally waives and agrees not to plead or claim in any such court that any such action, suit or proceeding brought in any such court has been brought in an inconvenient forum.
